

- Staffing concerns: contracted position, too few positions
- Lack of appreciation for cultural roles
- Homogenised Indigenous services

Elder & Knowledge Keeper Network: Interior Region

Solution:

- Creation of an Interior Region Elder & Knowledge Keeper Network
 - Members from different Indigenous Interior Communities
 - o Offer group and one-to-one teachings, ceremonies, and support to provincially incarcerated Indigenous folks in this region.



- Elders play an important role in sharing knowledge, culture, language, values, and life philosophies.
- Western perspectives on their own are ineffective in improving wellness of Indigenous peoples.
- Aligned with UNDRIP, Government of BC Rights of Indigenous Peoples Act, and Truth & Reconciliation Commission of Canada calls to
